

# Llangarron Community Association

## Lottery Club Rules and Share Certificate [at foot of page]



1. The name of the club is *Llangarron Community Association Lottery Club*, hereafter called ‘the Club’.
2. The object of the Club is to raise funds to support community projects in Llangarron parish. All surplus income over expenditure shall be paid to the Llangarron Community Association (LCA).
3. Each participant must be over 16 years of age and have an association with Llangarron parish.
4. The Club will seek to attain a minimum of 100 members and will run in periods of one year commencing in September. Should the number of members of the Club exceed 100 but not exceed 149 members, then the prize money allocation will remain as described. Should the number of members of the club exceed 150 then prize money will be adjusted to reflect the additional income. The Club will be run providing a minimum of 80 members has enrolled. If there are less than 80 members, the Club will not be run and funds will be returned.
5. The Club shall be managed and administered by the Llangarron Community Association (LCA). Monies shall be handled by the Treasurer of the LCA which has a bank account with two signatories. A separate set of accounts will be kept for the Club. Accounts and the register of members will be available for scrutiny, given reasonable notice. The LCA’s decision shall be final in any matter requiring adjudication. The Committee shall have power to amend or revoke these rules at their absolute discretion.
6. Participation in the Club shall be by payment of £24 per annum for each share, payable by cash, cheque, direct bank transfer or standing order annually by 1st September. Members whose payment has been received by 1st September in each year will be eligible for inclusion in the four quarterly prize draws.
7. A participant may hold more than one membership/share of the Club. Each membership will be allocated a share number or numbers. A list of membership numbers will be maintained and cannot be changed.
8. Should a member not renew their subscription by 1st September, they will NOT be entered in the following quarter’s draw and their number may be re-allocated. Subscriptions may be renewed or initiated at any time during the year, however, at a pro-rata rate, providing entry to the remaining draws in the Lottery Club year.
9. Quarterly cash prizes will be awarded in September, December, March and June. Three prizes will be awarded each quarter: the first prize will be £150, the second prize will be £100 and the third prize £50.
10. The winning numbers will be drawn at the Llangarron Community Cafés (or other suitable event) in September, December, March and June. Winners will be notified by e-mail or telephone. Results will be published on the Llangarron website ([www.llangarron.info](http://www.llangarron.info)), in the “Llangarron News” email newsletter and on the Llangarron Village Facebook page. Winners will receive their prize in the form of a cheque or direct bank transfer.
11. Participants can cancel their entry in the lottery by giving notice by the **31st August** each year in writing to the administrator (if paying by standing order, they should advise their bank) and membership will cease in September and they will not be entered into the September draw. Any decision to wind up the club will also be by one month’s written notice to all members by 31st July in the appropriate year. Under no circumstances can any payments be refunded.
12. The club is exempt from registration under the terms of Section 11 of the Gambling Act 2005 and is run as a private society lottery.
